

**REGISTRATION**

431. A copy of each Exhibits Registration Certificate (both sides) must be included with the Entry Form. Failure to provide a Registration Certificate with the Entry Form will deem that animal ineligible for Exhibition at the Show.

432. Only the registered owner of an Exhibit, or his/her authorised agent may sign an Entry Form.

HEALTH REGULATIONS

433. All entries must be accompanied by the Alpaca Herd Health Declaration Form signed by the Exhibitor or authorised agent, and a Government Veterinary Officer if applicable. Failure to sign the Alpaca Herd Health Declaration Form will render all Alpacas of an Exhibitor ineligible to be exhibited.

434. The 2012 Alpaca Competitions will be conducted under the guidelines as set out in the Johne's Disease Market Assurance Program (AlpacaMAP).

435. Alpacas traveling interstate must comply with the requirements of Victorian legislation.

EXERCISING OF ANIMALS

436. Alpacas are to remain in their pens during the day and exercising is only allowed at specified times (out of public hours, before 9:00am and after 10:00pm) or at times nominated by the Superintendent. Due to crowd congestion and entertainment activities that occur near The Weekly Times Livestock Pavilion animal safety cannot be guaranteed outside the hours specified.

COMPANION ANIMALS AND DOGS

437. Animals not entered for competition, with the exception of cria at foot, will not be permitted onto the Showgrounds. Companion animals are not permitted. This does not apply to the display alpacas.

No dogs (except guide dogs) are permitted into the precinct where Show animals are being penned or shown.

INSPECTION OF EXHIBITS

438. Inspection of all Alpacas will take place on Friday 21 September 2012 between 5:30 and 8:30pm and Saturday 22 September 2012 between 7:00am and 8:30am. All Alpacas must be registered with the IAR and carry an approved brass tag showing the Alpaca's IAR number.

439. Every animal exhibited in the Alpaca section will be subject to inspection carried out by an Inspector appointed by the RASV.

440. The Inspector or Inspectors appointed by the RASV shall then examine all Alpacas for genetic faults, colour, class and IAR number.

441. If there is no IAR tag present in the ear of an Exhibit, official confirmation by the registrar (in hard copy) must be provided by the owner to the Chief Steward that the ear tag has been recently lost and that the new tag has been ordered and paid for. Replacement tag orders and payments must be lodged with the registrar a minimum of one week before the date of Show. Failure to present such advice at inspection will result in disqualification of the animal.

442. No Exhibitor shall, to the best of their knowledge, exhibit any alpaca showing any signs or symptoms of disease at the time of exhibition. All male alpacas must be completely entire and deemed physically sound. Any alpaca not deemed to be completely physically sound by the appointed RASV Inspector or a Veterinary Surgeon shall not compete.

443. The Inspector or Chief Steward will classify all entries for colour, and has the power to transfer an Exhibit to the class which, in their opinion, should have been entered. The Chief Steward will combine or split classes as he / she sees fit.

444. Alpacas not in their allotted pens and available for inspection at the official times may be disqualified by the Chief Steward. Exhibitors must be in attendance at time of inspection and will be required to assist.

445. Exhibits of Huacayas must carry a minimum fleece length of 50mm and a recommended maximum length not exceeding 130mm. The minimum fleece length for Suris is 75mm and fleece length will be assessed by the Judge.

Note: Huacaya 12 months and older must be shorn regularly so that no more than 15 months fleece is carried at the time of showing. Suris must be shorn regularly so that no more than 24 months fleece is carried at the time of showing.

446. Any animal found to have lice infestation must be removed from the Showgrounds immediately along with any other Alpacas present that belong to the same Exhibitor.

CORRECT ANIMAL COLOUR CLASSIFICATION

447. An Alpaca is to be shown in the appropriate colour class, when it is predominantly that colour. Any colour variations will be assessed at the Judge's discretion.

448. A predominantly grey Alpaca (grey, rose grey) is to be shown in a grey class, whether or not it has any other coloured spots present, and any colour variations will be assessed at the Judge's discretion.

449. Exhibits shall not have fleece of a different colour to that of the blanket removed from an animal to a level below that of the blanket fleece.

AGE OF ALPACA

450. Alpacas must be entered into the correct class at their age on the first day of judging, Saturday 22 September 2012.

JUDGING

451. The following regulations shall be read subject to General Regulations 10.1 to 10.6 of the General Regulations.

452. Judging Times are as follows:

Huacayas

Fancies: Monday 24 September 2012 from 9.00am

Junior Huacaya: Saturday 22 September 2012 from 9.00am

Intermediate and older sections: Sunday 22 September 2012 from 9.00am

Supreme Championship, Best of Colour, Sire's/Dam's Progeny: Monday 24 September 2012 from -1:30pm

Suris

Junior Intermediate, and older Suris; Saturday 22 September 2012 from 3:00pm

Supreme Championship, Best of Colour, Suri Sire's/Dam's Progeny: Monday 24 September 2012 from 1:30pm

Junior Judging Monday 24 September 2012 from 9:30am

Junior Handling Monday 24 September 2012 from 11:00am

453. Section 1 through to Section 10 will be followed by all section champions "1-10" for the Supreme Champion.

454. The Huacaya Sire's and Dam's Progeny will proceed after the judging of the Huacaya Supreme Champion and "Royal" Colour.

455. The Suri Sire's and Dam's Progeny will proceed after the judging of the Suri Supreme Champion and "Royal" Colour.

456. The Judge's decision shall be final and the Judge has the power of withholding prizes from any Exhibitor not deemed worthy of that prize.

457. All Exhibitors shall, upon arrival at the Show, obtain their pen position and class numbers from the Shed Steward. Exhibitor class numbers of the Exhibit must be worn and clearly displayed by the handler whilst in the Show Ring and must show age of animal in months and the number of months of fleece the alpaca is carrying.

458. All handlers showing animals must be competent in the handling of their Exhibit, or removal from the Show Ring may be requested by the Judge. It is recommended that children not Exhibit large animals that they cannot control.

459. All Exhibitors must place their animals in the pens allotted by the Stewards and must not be moved or removed except by order of the Chief Steward.

MISCONDUCT OF EXHIBITORS AND MEMBERS

460. A violation of any rule by the Exhibitor shall be reported to the Chief Steward in writing by either the Judge, a steward or exhibitor within one hour of the alleged incident occurring.

461. Misconduct may also be reported by the Judge, a Steward or Exhibitor to the Chief Steward in respect of actions of an exhibitor or member present at the Show that is considered to be prejudicial to the industry. Such actions may include but not be limited to:

- A demonstration of dissatisfaction with a Judge's decision, including refusal to accept an award.
- Altercations with Show Officials, Exhibitors or the general public.
- Abusive or foul language or rude gestures in public and the mistreatment of an animal.



462. Written complaints shall be lodged with the Chief Steward within one hour of the alleged incident occurring. Written complaints received by the Chief Steward shall be immediately investigated and if sufficient grounds for the complaint are confirmed the matter shall be reported to the RASV for appropriate action under the appropriate Grievance Procedure.

PROTESTS

463. The following regulations shall be read subject to General Regulations 11.1 to 11.7 of the General Regulations.

464. Only an Exhibitor may lodge a protest against another Exhibitor or a Show official. The protest shall be lodged in writing together with a deposit of \$50, which shall be refunded if the protest is upheld.

465. The sole grounds for a protest shall be a breach of the Regulations and protests shall be lodged with the Chief Steward within one hour of the alleged incident occurring.

The Chief Steward shall set up a Protest Committee prior to the commencement of the Show. The Committee shall comprise the Chief Steward as the Chair and two ordinary members not associated with the alleged incident. A meeting will be convened within 30 minutes of the protest being received. The Protest Committee shall immediately investigate the protest and if found to be valid initiate appropriate action.

DRESS CODE

466. All Exhibitors leading stock in the Judging Ring or on Parade shall wear a white coat, black trousers or skirt and clean closed black shoes. No shorts or short dresses, open shoes or hats.

467. Such white coat uniform must in no way show any insignia or any descriptive markings indicating the Exhibitor's name and/or stud name or prefix.

468. The Chief Steward may disqualify an Exhibitor for incorrect attire.

EXCESS ENTRIES

469. In the event of more entries being received than can be accommodated, Alpaca entries may be reduced. If necessary, the number of Alpacas from any one Exhibitor may also be reduced to a figure determined by the RASV. The Exhibitor shall have the right to nominate the Alpaca(s) to be withdrawn should this reduction be necessary.

PRIZES

470. Ribbons may be awarded up to 6th place as follows:

Up to 10 exhibits per class: 1st, 2nd & 3rd ribbons.

11 to 18 exhibits per class: 1st, 2nd, 3rd & 4th ribbons.

19 to 20 exhibits per class: 1st, 2nd, 3rd, 4th, 5th & 6th ribbons.

The Judge is under no obligation to award the prize where he / she considers in his / her absolute discretion that such prize, or prizes, are not to be awarded.

SIRE'S PROGENY CLASSES

471. Group of three males, females or males and females-(no wethers), six months and over. Not necessarily owned or bred by the one Exhibitor, but all the progeny of the one sire and drawn from the Ordinary classes. The class will only be conducted if there are at least two entries.

472. Only one progeny from any one dam may be shown in each sires progeny group unless the progeny have been born at least eleven months apart.

473. Entries close for Sire's Progeny Class at a time determined by the Chief Steward and the Alpaca Superintendent. Exhibitors will be advised upon arrival at the Showgrounds of this time.

DAM'S PROGENY

474. Group of two males, females or males and females (no wethers), six months and over. Not necessarily owned or bred by the one Exhibitor, but all the progeny of the one dam and drawn from the Ordinary classes. The class will only be conducted if there are at least two entries.

475. Alpacas entered for the Dam's Progeny class may have the same sire or different sires and must be born at least eleven months apart.

476. Entries close for Dam's Progeny Class at a time determined by the Chief Steward and the Alpaca Superintendent. Exhibitors will be advised upon arrival at the Showgrounds of this time.

JUNIOR JUDGING

Judging will take place on Monday 24 September 2012 from 9:30am

477. Competitors to be aged between 15 - 25 years

478. Entrants are advised to attend an approved Alpaca Junior Judging workshop prior to the Junior Judging competition.

479. The competition will be conducted as follows:

- One group of four animals will be judged by the competitors.
- There will be one visual class and one oral class
- Dress code applies.

JUNIOR HANDLER CLASS

480. Entries accepted on the day of judging at a time nominated by the Chief Steward. Exhibitors will be notified of this time upon arrival at the Showgrounds.

MOST SUCCESSFUL EXHIBITOR AWARDS

481. RASV Sash will be awarded to the Most Successful Huacaya Exhibitor (S001) and Most Successful Suri Exhibitor (S002).

482. The Most Successful Exhibitor Award will be calculated as follows:

Classes with 1 to 10 entries: 1st, 3 points; 2nd, 2 points; 3rd, 1 point.
Classes with 11 to 20 entries: 1st, 4 points; 2nd, 3 points; 3rd, 2 points; 4th, 1 point.

483. Placings in Sire's and Dam's Progeny Class and Fleece Classes will not be taken into consideration when deciding these awards.

484. In the event of a tie, two points will be allotted for Champion awards and one point for Reserve Champion awards. If a tie still exists, a count back approved by the RASV, will be made to determine the winner.

THE BEST PREPARED AND MAINTAINED TEAM AWARDS

485. The aim of the award is to encourage Exhibitors to display and maintain their teams in a manner befitting the Alpaca Industry. The RASV will provide a Sash to the successful Exhibitor (S003).

486. Judging will take place from Saturday 22 September - Monday 24 September 2012.

Points will be awarded for the following items:

a) Groomed appearance of Alpaca	10 points
b) Condition and use of bedding	10 points
c) Condition of feeders and water	10 points
d) General tidiness of pens	5 points
e) Presentation of pens	15 points
f) Attendance, public relations	50 points
TOTAL	100 points

MOST SUCCESSFUL EXHIBITOR AWARDS

The Most Successful Exhibitor Award will be calculated as follows:

1 to 10 entries: First, 3 points; Second, 2 points; Third, 1 point.

11 to 30 entries: First, 4 points; Second, 3 points; Third, 2 points; Fourth, 1 point.

Placings in Sire's Progeny Class and Fleece Classes will not be taken into consideration when deciding these awards.

In the event of a tie, two points will be allotted for Champion awards and one point for Reserve Champion awards. If a tie still exists a count back, approved by the RAS, will be made to determine the winner.

RAS Sash will be awarded to the Most Successful Huacaya Exhibitor (S001) and the Most Successful Suri Exhibitor (S002)
